

ReD UK DIESEL Apply Online Promotional Terms and Conditions

- This Promotion is open to all companies registered in the UK (excluding employees of or companies connected with employees of ReD Fuel Cards (Europe) Limited, their immediate families, agents or anyone professionally connected with the Promotion) who successfully complete and submit a ReD UK DIESEL fuel card online application form by filling in all the required details via the online registration process between 00.00am on 30/03/09 to 00.59pm on 31/05/09 (the "Promotion Period").
- All online registration forms must be submitted to ReD Fuel Cards electronically and received electronically by ReD Fuel Cards (Europe) during the Promotion Period for you to become eligible for up to £20 off your first ReD UK DIESEL fuel card account invoice (the "Promotion"). Where your first ReD UK DIESEL fuel card account invoice is for an amount over £20, you will be eligible for the full £20 sum to be deducted from your first invoice total. Where your first ReD UK DIESEL fuel card account invoice is for an amount under £20 you will be entitled to the equivalent amount owing (up to £20) to be deducted from your first ReD UK DIESEL fuel card account invoice. For the avoidance of doubt, no amounts shall be deducted from your second and subsequent account invoice regardless of whether your fuel account invoice is for less than £20 or not.
